# Meeting of the Town Council of Huntertown, Indiana Monday, November 20, 2023, 6:00 p.m. Huntertown Town Hall, 15617 Lima Road

A public meeting of the Huntertown Town Council was held on Monday, November 20, 2023, at Huntertown Town Hall, 15617 Lima Road, Huntertown, IN. Present were board members Brad Hite, Tina McDonald, and Brandon Seifert (P); Town Manager Beth Shellman; Clerk-Treasurer Ryan Schwab; Derek Frederickson of Engineering Resources Inc.; thirteen (13) members of the public and one (1) member of the media. Absent were board members Michael Aker and Patricia Freck.

Brandon Seifert called the meeting to order at 6:00 p.m. with the Pledge of Allegiance.

# **COUNCIL ACTION**

Tina McDonald made a motion to approve the minutes from the November 6, 2023, regular meeting. Brad Hite seconded. Motion carried 3-0.

Brad Hite made a motion to approve the General, Water and Sewer claims dated November 20, 2023, in the amount of \$919,177.51. Tina McDonald seconded. Motion carried 3-0.

Tina McDonald made a motion to approve Huntertown Resolution 2023-032, a Resolution approving the purchase of real property and authorizing the Huntertown Town Manager to act on behalf of the Huntertown Town Council in making the purchase. Brad Hite seconded. Beth Shellman covered the details of the resolution, which covers the property at 2123 Trinity Street. After no further discussion, the motion carried 3-0.

Brad Hite made a motion to approve Huntertown Resolution 2023-033 through 2023-038, street acceptances for the following subdivisions: Bluffs of Carroll Creek (033); Cascata Estates Section II (034); Sonora Section I (035); Hunter's Reserve Section I (036); Emerich Hills Section 1 (037); and Marcella Section II (038). Tina McDonald seconded. Motion carried 3-0.

Brad Hite made a motion to approve the 5-year pavement asset management plan as presented. Tina McDonald seconded. Motion carried 3-0.

Tina McDonald made a motion to approve a professional engineering services agreement with Engineering Resources Inc. in the amount of \$125,900.00 for the reconstruction of Apollo Drive, Gemini Drive and Mercury Lane in Huntertown. Brad Hite seconded. Motion carried 3-0.

Brandon Lockhart, representing the Shoppes at Copper Creek, addressed the council and thanked them
and the community for its support. Ground has been broken and the development looks forward to
being a vital part of the community.

Clerk-Treasurer Ryan Schwab had the following report:
