HUNTERTOWN GOLF CART REGULATIONS

THESE REGULATIONS APPLY FOR GOLF CARTS DRIVEN ON ROADWAYS AND IN NEIGHBORHOOD ADDITIONS

OPERATOR MUST HAVE A VALID DRIVER'S LICENSE.

OPERATOR MUST OBEY ALL RULES OF THE ROAD AND TRAFFIC REGULATIONS.

PASSENGERS ARE LIMITED TO THE NUMBER OF PERSONS FOR WHOM FACTORY SEATING IS INSTALLED.

PASSENGERS 10 YEARS OF AGE OR LESS MUST RIDE IN THE FRONT SEAT.

GOLF CARTS CANNOT BE DRIVEN ON THE SIDEWALK EXCEPT TO CROSS OVER AT A RIGHT ANGLE TO ACCESS ADJOINING PROPERTY OR ANOTHER ROADWAY.

GOLF CARTS MUST BE REGISTERED WITH THE TOWN HALL AND REGISTRATION MUST BE DISPLAYED ON THE CART AT ALL TIMES.

GOLF CARTS MUST BE INSURED.

GOLF CART MUST HAVE:

1. REAR VIEW MIRROR
2. SLOW MOVING EMBLEM/PLACARD
3. AMBER LIGHT/FLASHING LAMPS
4. HEAD LIGHTS AND TAIL LIGHTS
5. BRAKE LIGHTS

A VIOLATION OF THESE PROVISIONS IS CONSIDERED A CLASS C INFRACTION AND CAN RESULT IN FINES AND PENALTIES.
